11. SUMMARY

- 11.1 The UIM Independent Hearing Panel determined that Mr. Nadir Bin Hendi (in UAE Passport Nadir Mujtahid Ali Bin Rahal) be:
- 11.2 Disqualified from the UIM XCAT World Championship 20-21 July 2024 Palermo (Italy), and all other competitive results of the Athlete, obtained from the date of the sample collection to the date of his provisional suspension shall be disqualified with all of the resulting consequences, including forfeiture of any medals, points and prizes.
- 11.3 Sanctioned with the ineligibility for 4 (four) years commencing on November 20, 2024 in accordance with the UIM's Anti-Doping Rules. From this period, the period of his provisional suspension should be subtracted.
- 11.4 Sanctioned with the sum of € 4.000,00 (four thousand euro) as financial consequence ex 10.12.1 of the UIM ADR.

12. PUBLIC DISCLOSURE

12.1 This decision will be made public pursuant to Art. 14.3 of UIM's Anti-Doping Rules.
