

TERMS AND CONDITIONS FOR PARTICIPATION

Introduction

The Union Internationale Motonautique (UIM) is the world governing body of Powerboating, Aquabike/ Jet-Ski, MotoSurf and Electric Powerboating, fully recognized by the International Olympic Committee and member of GAISF, the General Association of International Sport Federations, and of ARISF, the Association of the IOC Recognized International Sport Federations. The UIM governs all Powerboating disciplines including Aquabike, Circuit, Offshore, MotoSurf, Pleasure Navigation & Electric (E1 Series).

The UIM acknowledges that every activity correctly conducted on water – large or small – can make a difference in the fight against climate change and help to solve today's environmental challenges, from the decline in biodiversity to the unsustainable use of energy resources. The UIM seeks to promote cooperation between recreational competitive Powerboating, the marine industry and research centers in all environmental areas and recognizes the importance of sharing knowledge and best practices.

In order to inspire and recognize excellence in innovation, development and application of environmentally friendly technologies the UIM is delighted to launch the: "2023 UIM Environmental Award"

Eligibility

UIM National Authorities, partners, racing teams, boat builders, engine manufacturers, universities, research centers, scientists, Non-Governmental Organizations (NGO's), companies and individuals are eligible for the 2023 UIM Environmental Award. This award recognizes outstanding environmental leaders, whether individuals or organizations that have excelled in inspiration vision, innovation, leadership and initiatives to the benefit of the Environment.

Project applicants should be able to demonstrate significant accomplishments that have occurred prior to the submission deadline. The Award can be won through concrete and proven actions in favor of the protection and safeguard of water and environment in all types of motor boating activities, be it a major contribution or a small one, such as processes whereby goods and/or services in use in these motor boating activities can be made to have a smaller environmental footprint, or even a process whereby activities, events, competitions are conducted in more environmentally friendly manner. Your imagination sets the limits.

THE AWARD

2023 UIM ENVIRONMENTAL AWARD WINNER

The winner can use the UIM logo with the statement "Winner of the UIM Environmental Award" preceded by the year in which it was won.

The logo can only be used by the winner in accordance with the UIM policies.

The Award may be revoked if it is discovered that a winner has provided misleading or erroneous information within the submission or it is subsequently discovered that the submission infringes the intellectual property rights of third parties, or has made inappropriate use of the UIM logo.

Amongst the entered applications the following special mentions will be selected through the criteria of Economic Feasibility, Environmental Benefit and Greening the Sport.

Publicity

The UIM reserves the right to publish details of the nominees, entrants, finalists, and winners of the Award on the UIM website and in other promotional and advertising material as it considers appropriate, including the purpose of promoting the UIM Environmental Award. By entering, entrants agree that they will be willing and available to participate in public advertising and promotional activities and events and/or press conferences and that UIM shall be entitled to use entrants' names, photographs, country of residence and other relevant information in publicity throughout all media.

Entrants shall not take part (or agree to take part) in any media coverage, or make any press releases or other announcements regarding participation in the Award without the prior consent and agreement of the UIM.

Entries

Entries will not be returned. Entrants may be required to provide further information to assist in assessing the submission and each entrant agrees to fully co-operate with this process. Information which is not in the public domain and is marked by the entrant as confidential shall be treated as confidential by the UIM.

The entrant warrants that it has truthfully and accurately completed the submission and acknowledges and agrees that the UIM may at its sole discretion disqualify the entrant from the Award at any stage if the entrant has provided any untruthful, inaccurate or misleading details or information in the submission and/or has failed to respect the terms and conditions of participation.

The entrant warrants that it owns the intellectual property rights relating to the submission or has obtained any licenses required to use the intellectual property rights relating to the submission. As between the UIM and the entrant, the entrant shall retain ownership of any intellectual property rights in its submission.

The UIM may decline to submit a nomination or consider a submission if, at the sole discretion of the UIM, the submission infringes the intellectual property rights of a third party. Any such decision shall be final and non-appealable. The decision of the UIM shall be final and non-appealable. The UIM shall retain any and all nominations and submissions (or materials pertaining to them) and may use such materials, nominations, and submissions at its own discretion.

The selection

The selection of a maximum of three finalists among the entrants will be done by a selection committee set-up by the UIM and the final decision on the Award will be taken by the UIM Executive Committee.

The selection committee reserves the right to seek external advice and guidance from such other experts as they consider appropriate, including but not limited to advice relating to the originality of the submission and whether the submission infringes the intellectual property rights of a third party.

No member of the selection committee shall (a) have personal or financial interests in, or be an employee, officer, director, or agent of any entity that is a registered participant in the Award (or sponsor or financiar of any such participant); or (b) have a familial or financial relationship with an individual who is a registered participant or participant sponsor.

Judging

Final judging of all submissions will be conducted by the UIM Executive Committee. In this role, the UIM Executive Committee reserves the right to seek external advice and guidance from external experts. As set out above, the UIM Executive Committee's decision shall be final and non-appealable.

Liability

The UIM accepts no liability for entries lost, damaged or delayed in transmission and proof of submitting an entry is not proof of receipt.

Important information

The UIM reserves the right to modify these Terms and Conditions of Participation as necessary during the term of the challenge. The UIM will update registered entrants or related parties as appropriate as to any such modifications.

Governing Law

The Terms and Conditions of Participation are governed by and interpreted in accordance with the laws of the Principality of Monaco.

The courts of Principality of Monaco have exclusive jurisdiction to settle any disputes which may arise in connection with the Terms and Conditions of Participation.
