MISSION

The purpose of this presentation is to summarise and explain the Anticontagion Safety Protocol (ASP) put in place by H2O Racing based on the general requirements of the WHO and in accordance with the UIM practice.

The result is a series of measures and precautions finalised to minimise any risk of Contagion for all the participants to H2O Racing Events.

The guidelines proposed by H2O Racing shall be submitted to the local health and safety authorities and adapted/amended according to the local regulations.

CLASSIFICATION OF AREAS

H2O Racing has divided the event in 2 Macro-areas

- Areas Open to Public
- Areas with restricted access (Pass needed)
 - Way in and out/transit areas
 - Short stay
 - Extended stay (offices etc)
 - Gathering when wearing PPE
 - Gathering without PPE

RISK ASSESSMENT

Exposure

Probability of coming into contact with sources of contagion when carrying out specific activities in hazardous places and consequent damages.

Proximity

Characteristics of carrying out the activities requiring and/or close contacts the attendance to events not always allowing sufficient social distancing (i.e. within 1 meter)

Aggregation

Jobs involving contact with other subjects in addition to H2O staff such as (teams, local, TV)

ACTION PLAN

The following guidelines are the result of the previous combined matrix

BEFORE THE EVENT

- Operatives with high fever or a new persistent cough will not be allowed on site and must stay at home;
- Moreover any underlying health conditions or clinical conditions will not be allowed on site and must stay at home;
- Operatives living with someone in self-isolation or with a vulnerable person will not be allowed on site and must stay at home;
- To make 2 swabs, or similar recognised test by WHO (with negative results) 5 days and 2 days before travelling*
- To travel to the venue strictly abiding by the local rules and regulations (i.e. PPE)
- When possible to reach the airports by private means of transport (i.e. own car)
- When possible to choose direct flights or itinerary with less stopover

*if required by the LO. In this case LO should have an alternative option to take a swab upon arrival

COMMUTING TO PADDOCK

In accordance with LO when possible the staff should be staying in hotels at walking distance to the paddock facilities. If this is not possible an adequate shuttle service should be put in place in accordance with local rules and regulations (max occupancy, PPE, no A/C, etc.)

ACTION PLAN

The following guidelines are the result of the previous combined matrix

Paddock Access

- Access to paddock is strictly limited to Key people working for the event.
- The full list of participants must be available before the beginning of the event.
- No visitors or teams guest are allowed to enter the paddock.
- Staggered entry and Timings
- The full list of participants must be available before the beginning of the event.
- Limited number of team staff for each team including: F1 (2 drivers 6 mechanics, 2 radio men, 1 team manager.)
Aquabike Runabout (1 Rider, 2 Mechanics) Aquabike other categories (1 Rider, 1 Mechanic)
- Entrance subject to sanitize (Sanification Gate) and temperature control (max 37.5)

ACTION PLAN

The following guidelines are the result of the previous combined matrix

PADDOCK ACTIVITY

- Permanent personal passes with name and picture
- To limit aggregation opportunities
- Limited number of workstations - In & Out and Transit procedures
- 2 separate media center, one reserved exclusively for the International Press, the other for local press managed by LO
- No large group meetings: limit all briefing to 2 persons per team or meetings. Meetings to be held with personal distance between individuals.
- When possible Meetings are to be rescheduled with the use of conference calls, facetime, video conference, etc. in lieu of in person meetings.
- Minimum interpersonal distance required 1 meter (or as per local rules).
- Restricted use of all common areas, offices, locker/ drying rooms, meeting rooms and others
- In case the minimum safety distance cannot be kept, for the safety procedures observe behavioral rules wear applicable masks
- Protective material to be provided and have always in stock: disposable surgical masks, nitrile gloves, FFP2 and FFP3 masks, clear plastic sneeze guards (reception, offices, media centre), protective goggles. Standard PPE kit to be regularly inspected and replaced, no-touch trash receptacles, thermometers to measure body temperature. Safety and warning signage products for the sanitation of the premises, hand soap and alcohol based hand wash.
- For all H2O workers provision of personal bag containing PPE Kit including gloves, helmet, shoes, goggles, face masks suitable for their specific work.

ACTION PLAN

The following guidelines are the result of the previous combined matrix

OFFICES

- Access to offices is limited to relevant person
- Max 1 person at time can access the office
- Every workstation must have plexiglass screen and should be sanitised at the end of each day
- When possible no A/C but natural air ventilation

TEAM TENTS

- Each Team tent is considered as standalone environment and its team members as individual core. For this reason access to each tent is strictly permitted to its team members only. Each team must appoint one person responsible of liaising on behalf of the team: Other teams, H2O Crew, UIM Commisioners, Secretariat, etc,
- Each team must appoint one person responsible
- Each Team must abide with local rules and regulations in particular sanitary measures (PPE, hand washing etc).
- Cancellation of F4 and limitation of team members will facilitate internal interpersonal distancing.
- When Teams must bear specific tasks that cannot consent social distancing (pontoon, engine tuning, etc) use of disposable PPE is compulsory.

ACTION PLAN

The following guidelines are the result of the previous combined matrix

TIMING - RACE CONTROL

- Presence in the timing container is strictly allowed to time keepers, timing director, UIM Commissioner and Race Directors
- The presence of time keepers in the timing must be limited to the time of the session.
- General cleaning of surfaces and in particular glass before and after each session.
- Keep the container ventilated between the sessions
- PPE: mask

TOILETS

- Toilet can be used by one person at the time
- Portable toilets will be avoided as much as possible but when necessary these should be cleaned/emptied more regularly;
- All toilet facilities used must be thoroughly cleaned after used, particularly door handles, locks and toilet flush;
- Dedicated personnel must be present at all time during opening hours to clean and sanitize and remove all the disposals.

ACTION PLAN

The following guidelines are the result of the previous combined matrix

MEALS

- To avoid gatherings all meal should be preferably arranged with lunch boxes, disposable drinks to be consumed in separated areas. (i.e Teams in their own tents)

PRIZE GIVING CEREMONY

- ONLY WINNERS OFFICIAL PHOTOGRAPHERS and TV CREW AND PODIUM CREW
- Press conference to be organised open air on the podium immediately after the prize giving

ACTIVITIES THAT CAN BE CANCELLED

- Vip Tent
- Paddock Tour
- Swimming Pool Kids
- Media Tour
- Two Seater

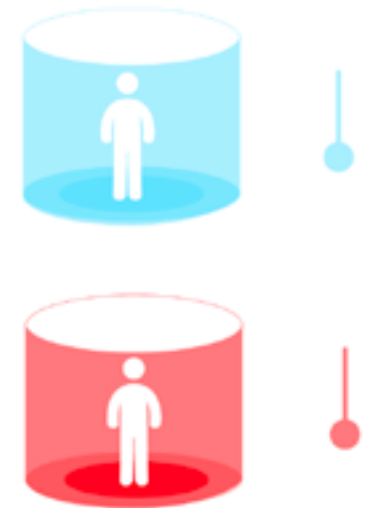

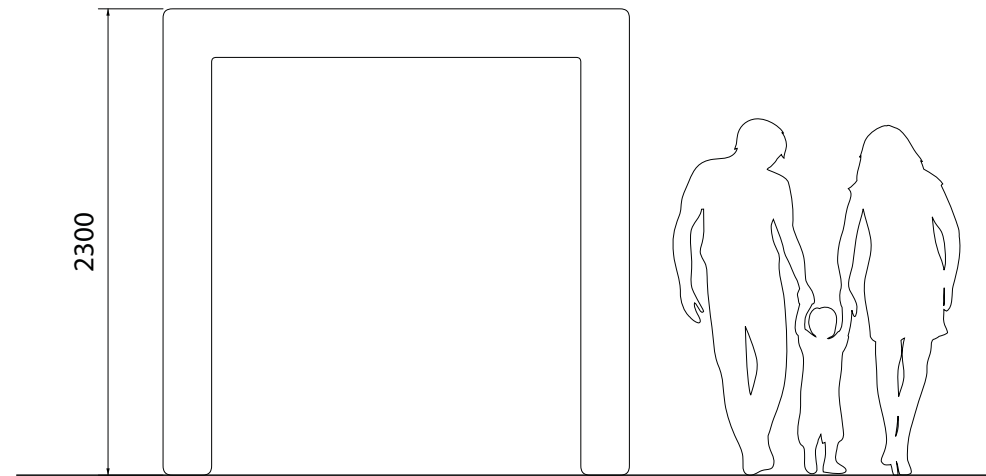

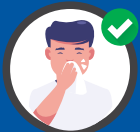
